Creating Certainty for the Future of Geriatric Medicine

The MGH Senior Health Practice was founded with a collaborative approach to senior care, which places the patient at the center of an interdisciplinary team. On October 9, 2013, MGH hosted a celebration to honor the establishment of the MGH Endowed Chair in Geriatric Medicine, and the appointment of Kenneth Lloyd Minaker, MD, as the inaugural incumbent.

The event, held at the Four Seasons Hotel, was attended by more than 140 colleagues, family members and friends of Dr. Minaker.

Peter Slavin, MD, opened the program and thanked Dr. Jack Rowe, Valerie Rowe, Harry and Rita Patten, and the Patten Family Foundation, for their lead matching grants totaling \$1 million. All spoke of the accomplishments and leadership of a truly distinguished physician. Dr. Slavin's re-

This chair represents the first endowed chair in primary care medicine at Massachusetts General Hospital, and upon Dr. Minaker's retirement the chair will be renamed the Kenneth Lloyd Minaker, MD, Chair in Geriatric Medicine. This chair will provide a permanent source of financial support for the MGH Senior Health Practice, thereby helping future generations of physicians keep pace with the growing needs of the country's aging population, while also honoring Dr. Minaker's numerous achievements in and contributions to geriatric medicine.

Valerie Stone Named Chief of Medicine at Mount Auburn

Valerie Stone, MD, MPH, Director of the Primary Care Internal Medicine Residency Program, will be leaving MGH to become Chair of the Department of Medicine at Mount Auburn Hospital. Her departure will be bittersweet, for as sad as we are to see her leave her post in the DGIM, we couldn't be more happy she has been afforded such a great opportunity and we look forward to her continued success at Mount Auburn.

Dr. Stone has held multiple leadership positions since arriving at MGH in 2001. Dr. Stone has served as an Associate Chief in our division since her arrival

and she assumed her current post as Director of the Primary Care Internal Medicine Residency Program in 2003. Additionally, Dr. Stone served as the Director of the Women's HIV/AIDS program here at MGH from 2003-2008.

Dr. Stone's time at MGH has been nothing short of exemplary, highlighted by a plethora of superlative achievements. Notable amongst these achievements was Dr. Stone's promotion to full Professor at Harvard Medical School in 2011. With that promotion, Dr. Stone became the first African-American women faculty member at MGH to

achieve the rank of Professor at HMS.

In addition to becoming Chief of the Department of Medicine at Mount Auburn Hospital, Dr. Stone has also been named the Charles S. Davidson Professor of Medicine at HMS.

A farewell reception in honor of Dr. Stone's achievements will be held on May 7th from 5-6:30 in the Thier Conference Room.

A search committee, chaired by Mark Eisenberg, MD, has been established to fill Dr. Stone's position.
